- b. It should be noted that the Trust can only make grants for the purposes of relieving financial hardship, sickness and poor health amongst elderly people.
- c. Preference will be given to applications on behalf of persons living in and around Much Wenlock.
- d. When an application has been received and considered, the applicant may be contacted and a visit to the applicant arranged. With the applicant's consent, further information may be sought from a doctor, social worker or other relevant person.
- e. All information given in respect of an application will be treated as strictly confidential and will only be seen by the Trustees and officers of the Trust. Information will not be disclosed to any other person or organisation without the prior consent of the applicant.
- f. The following is a list of some of the purposes for which financial assistance to individuals may be considered:
  - Funding towards the costs of medical equipment, e.g. wheelchairs, recliner chairs, specialised beds, hoists, nebulisers etc. (Two quotes will be required).
  - Funding towards limited nursing care at home.
  - Travelling expenses for hospital appointments or to visit a relative in hospital.
  - One off grants towards respite care for severely disabled/mentally ill patients to give carers a much needed break.
  - Applications will NOT be considered for:
    - Building extensions/home improvements
    - Grants to cover household bills
    - Retrospective grants
  - Grants will NOT be given for items/services readily obtainable from central and local government.
